**Amendment #19-05:** To add provisions to Article 13, Section 13.20 for a Temporary Dwelling Occupancy during the construction of a dwelling.

**Amendment # 19-03:** To add provisions to Article 3, Administration and Enforcement, Section 3.08 Fees, to establish escrow fees in addition to the basic application fee.
